The Innovation, Competition & Regulation Law Center at Korea University Law Institute (hereafter referred to as the "ICR Law Center") was founded on September 9th, 2010. The ICR Law Center specializes in expert, interdisciplinary research on theoretical and practical issues that arise in the context of Competition, Regulatory, Communications and Intellectual Property law with a market-based perspective.

During the first half of 2011, the ICR Law Center officially started its activities in various fields with a focus on interdisciplinary studies. We note the success of the 5-part Intellectual Property Rights (IPR) Seminar Series. This seminar series was attended by numerous domestic and foreign experts and made a significant contribution to academic research in the field. In addition, our Distinguished Speaker Series Lectures and specialized Case Study Seminar were also successful in establishing a systematic foundation for the ICR Law Center's initiatives. Finally, the last major project of the first half of 2011, a seminar on the currently-hot topic of nuclear risk was completed in success.

In celebration of the ICR Law Center's 1-year anniversary, we plan to hold a founding ceremony in the second half of 2011 to further our efforts and initiatives. In addition, we plan to host a series of seminars on issues facing a technological society along with an international seminar on nuclear energy. 
Debut of new scholars

◆ Regulations over Intellectual Property Rights Licensing Seminar Series (the "IPR Licensing Regulation Series"), *Prologue & New Scholar's Forum* (Feb 11, 2011)

The first project of 2011 was a series of seminars on 'Legal Regulation regarding Intellectual Property Rights Licensing'. As a prologue to this seminar series, new upand-coming scholars who had just received their doctorate degrees in related fields were given the opportunity to make their debut to the academia. Professor Ho-Jin Son of Hankyung University, Attorney/Director Sang-Joo Lee of Samsung Electronics and Researcher Mirang Shim of KIIP discussed their dissertations, followed by discussions with Professor Du-Jin Kim of Bukyung University, Professor Won-Mo Ahn of Hongik University, and Chief Prosecuting Attorney Ki-Young Kim of Suwon District Court.


The first seminar of the series addressed issues regarding TPR Licensing in the Software Industry'. The first part of the seminar started off with a keynote speech on IPR licensing regulation policies by Professor Sang-Jo Jung of Seoul National University and Section Chief Tae-Hyun Choi from the Office of the Secretary of State. In the second part, presentations were made by Professor Jae-Pil Choi of Michigan State University, Professor Seung-Woo Son of Danguk University, and Professor Chul-Nam Lee of Chungnam University; Professor Ki-Ho Yun of Korea University, Attorney Sung-Wook Eun of Yulchon Law Firm, Attorney Jae-Hoon Jung of Google, and Section Chief of Service Surveillance at the Fair Trade Commission Chul-Hyun Kwon. This first seminar aimed to introduce various opinions on current issues in IPR licensing regulation in a balanced manner and marked a meaningful start of the seminar series.

◆ Distinguished Speaker Series II: *Technology Licensing in the context of Standardization*, D. Geradin of the University of Michigan Law School (Mar 2011)

Professor Damien Geradin of University of Michigan Law School was invited to give a lecture on 'Technology Licensing in the context of Standardization'.

◆ Distinguished Speaker Series III: *Competition Policy and Economic Development*, A. Abbott of the U.S. F.T.C. (Apr 2011)

Deputy Director Alden F. Abbott of the FTC was invited to give a lecture on 'Competition Policy and Economic Development'.



This seminar was held to address issues in the IT industry as we recognize the IT industry as the main workhorse of Korea's economy. This seminar focused on Standard Settings, FRAND Conditions, and Cross Licensing. # ◆ 6th ICR Law Center Seminar, *New Online Services and User Protection*, in collaboration w/The Consumer Law Society (May 2011)

The Korea Consumer Law Society and the ICR Law Center held a joint seminar on 'New Online Services and Consumer Protection' with presentations by Professor Young-Woo Park of the Korea Internet Promotion Association, Professor Donun Kim of Busan University, Professor Seung-Woo Son of Dankuk University, and Professor Hyunsoo Kim of the Korea Consumers Association. A lively debate was held between Section Chief Soonmi Lee of the Fair Trade Commission, Professor Youngsoo Shin of Kyungbuk University, Attorney Jihyun Park of Taepyungyang Law Firm, Professor Kyungsook Kim of Sangmyung University, Head of the Korea Internet Corporations Association Minsik Choi, Professor Seil Ko of Baejae University, Section Chief Kyungjae Sung of the Fair Trade Association, and Professor Hee-Suk Seo of Busan University. The 4<sup>th</sup> IPR Seminar was held to provide a comprehensive summary on the various issues addressed in the last 3 seminar series. Attorney Kerin Coughlin of Constantine Cannon Law Firm (US), Professor Meng Yanbei of Renmin University (China), Attorney Hyun-Ah Kim of Sejong Law Firm, Attorney Hwansung Park of Kwangjang Law Firm, and Sang-seob Noh, Section Chief of Market Surveillance Activities at the Fair Trade Commission, participated as presenters while Director Chung-kon Ko of LG Electronics, Section Chief of Industry Asset Policies at the Korea Intellectual Property Office Tae-man Kim, and Professor Daesik Hong of Seogang University participated as debaters, all of whom contributed to a meaningful discussion.

#### ◆1st ICR Law Center Case Study Seminar, *Hynix v. Rambus* (Jun 2011)

Upon hearing news that Hynix Electronics won the Rambus Trial in U.S. Courts, the ICR Law Center invited Attorney Kyung-Hyun Min, Head of Intellectual Property at Hynix and Legal Head in the suit against Rambus, to present a case study. By explaining the industry's competitive corporate policies and the proceedings of the trial, he indicated the necessary perspective that a corporate lawyer needs in order to understand a given case and what the main issue of this case was. American attorney Hojin Jang of Yulchon Law Firm and Professor Yosub Choi of the Legal Research Lab at Hanguk University of Foreign Studies participated in the discussion.

# ◆ 7th ICR Law Center Seminar, *Technological Neutrality and Market Innovation* – *How to Improve Security on the Financial Networks*,

in collaboration w/National Assembly Member Lee, Sung Hun & the National Assembly Research Service (Jun 2011)

The ICR Center, along with the National Assembly Research Service and National Assembly Member Sung-Hun Lee, held a seminar focused on security in financial networks. Held in the Grand Conference Room at the National Assembly Library, this seminar discussed issues of finance security and the viability of vaccine programs and/or password programs. The discussions led to a consensus that the time has come for a more holistic and balanced approach regarding the psychological, social, economic, corporate, and policy-related aspects of security on financial networks.

# ◆ 8th ICR Law Center Seminar, *Legal Framework of Nuclear Energy Risk Management*, in collaboration w/Administrative Law Theory and Practice Society (Jul 2011)

In light of the recent nuclear plant crisis in Japan, the ICR Law Center held a symposium with the Society for Administrative Law Theory and Practice. This symposium was aimed at providing a rational and productive forum of discussion regarding nuclear security policies. It was a meaningful conference that introduced nuclear risk-management policies in other countries and its implications for Korea. In the first session entitled 'Comparative Studies Regarding Nuclear Law', Professor Byung-Hyo Moon of Kangwon University and Researcher Hye-Sun Yoon of Seoul National University made comparative presentations; in the second session entitled 'The Main Issues of Korean Nuclear Law and Future Strategies', Researcher Tae-Ho Kim of the National Court of Justice and Professor Chul-Hoon Ham of Seoul National University gave presentations. Professor Sang-Duk Moon of the University of Seoul, Professor Hee-Jung Lee of Korea University, Professor Kye-Soo Lee of Kunkook University, and Attorney Ho-Chul Kim of Kankyulhanwool Law Firm participated in the discussion.
